Dear Ms. Hoopes:

We are writing to give you notice pursuant to the provisions of the Worker Adjustment and Retraining Notification Act (WARN) that there will be a mass layoff / plant closing at Dream Center Education Holdings, LLC's The Art Institute of Colorado employment site located at 1200 Lincoln Street, Denver, CO 80203 on August 28, 2018. This mass layoff/plant closing is expected to be permanent.

All affected employees have been notified as of June 29, 2018 of their anticipated separation dates and that their separation from employment will be permanent. All employees are expected to be separated from employment as of December 31, 2018.
